# Support for providers using Change Healthcare as their EDI Clearinghouse

On Wednesday, Feb. 21, 2024, Change Healthcare — an independent company — experienced a cybersecurity incident.

Blue Cross Blue Shield of Michigan and Blue Care Network systems weren't affected by this incident and, at this time, there is no indication from Change Healthcare of any member impact.

However, we know some of our network partners use Change Healthcare to support core transactions, such as eligibility and benefit checks and claims submission. Blue Cross Blue Shield of Michigan and Blue Care Network are here to support you and avoid negatively affecting member care.

Here are some options for you to consider:

## Checking member's eligibility and benefits

You can check member eligibility and benefit information:

- Through the Blue Cross and BCN provider portal (<u>availity.com</u>\*)

### Submitting claims, checking claims status and viewing remittance advices

- Don't submit paper claims, as this will delay payments.
